#### I. Welcome

The meeting began at 10:36 a.m. Cindy welcomed everyone to the meeting.

#### II. Introduction of Martha Clare Morris, ScD

Melissa introduced Dr. Morris who is a Professor in Department of Internal Medicine, Division of Digestive Diseases and Nutrition and, Director of Section of Nutrition and Nutritional Epidemiology and Assistant Provost of Community Research at Rush University Medical Center.

Dr. Morris' research focuses on dietary patterns and its effect on cognitive decline. Her early key findings were that the consumption of vegetables and berries protects brain function. This helped Dr. Morris develop a diet specialized in Alzheimer's disease and dementia prevention, the MIND Diet.

Dr. Morris discussed the history of diet study and provided an overview of the results. There was a significant slowing in the rate of cognitive decline by people who followed the MIND Diet. She also provided general recommendations from the diet. Dr. Morris discussed her current work with the Memory and Aging Project and the US Pointer Study and hopes to report back to our group on their findings.

#### **III**. **Approval of April Minutes**

Cindy asked for approval of the April minutes. The minutes were approved.

#### IV. **Bylaws Revisions**

Cindy reminded everyone that bylaws changes were provided to members and copies are on the table.

Katie outlined the following revisions to Bylaws:

- 1. The name of the Contributor Committee will change to Annual Appeal Committee in the Bylaws and Policy and Procedures to more closely align with the committee's activities.
- 2. The Winnetka Auxiliary Cook Tour Chairs will now participate in voting on the principle project, as approved by vote of the Executive Committee in September 2018.
- 3. The Past President and Past Gift Shop Chair will join the Finance Committee membership for one year following the completion of their terms as they have historical knowledge that will contribute to the transition and consistency.

- 4. The Finance Committee has been working with the Rush Treasury Department to agree on an alternative procedure for an annual financial review rather than an annual financial audit. The Bylaws will reflect this option.
- 5. An inconsistency in the listing of Benefit Committees in the Bylaws and Policies and Procedures has been corrected to align the two documents.

Cindy reported that the Winnetka Auxiliary has revised its Bylaws to more closely align with their structure and our Woman's Board Bylaws. They were approved by the Winnetka Auxiliary and Executive board.

Cindy asked if there were any questions. Cindy called for a vote on the bylaws changes and the revisions were approved. Cindy thanked Katie and her committee, and Michelle Boardman for working with legal to get the changes completed on time.

#### V. Finance

### **Gillian Stoettner**

Gillian reported that the Finance Committee held their appropriations meeting on April 30, 2018 at the Woman's Athletic Club. The Executive Board met on May 20, 2019 and voted to present the appropriations to the General Board.

The total recommended appropriations for 2019 is \$405,131.16, with \$49,000 coming from the Winnetka Auxiliary and Jr. Board.
