- **Medical Staff Education and Well-Being** – Offering continuing education, mentorship opportunities, and mental well-being initiatives for health care workers

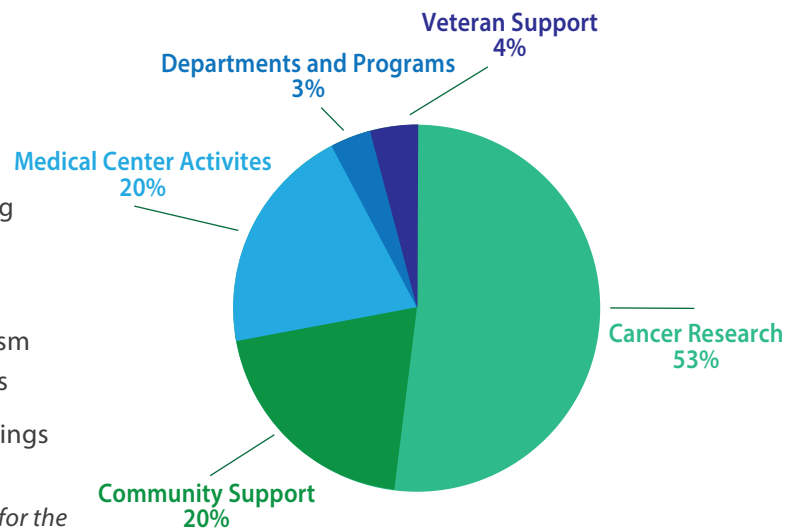
- **Rush Day School** – Providing education for children with autism spectrum disorders and/or children with emotional disabilities

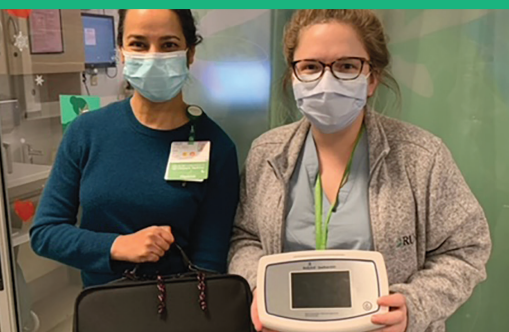
