## Momentum and Mission: 2022 Annual Impact Report

Extraordinary advancements are made when someone bravely moves first. For 139 years, RUSH and The Woman's Board — together — have been those first-movers in health care. The impact of this meaningful partnership can be seen across the world-class health care organization RUSH is today.

RUSH is now able to reach more patients than ever before. After three years of construction, the impressive 10-story Joan and Paul Rubschlager Building opened its doors in January 2023, expanding physical capacity for higher patient volumes. The building's inviting Woman's Board lobby welcomes RUSH patients as they arrive for world-class outpatient cancer, neuroscience and digestive diseases care. RUSH also announced a new partnership this year with CVS Health that expands Medicare patients' access to RUSH clinical services in the Chicago area. The partnership fulfills both organizations' commitment to delivering affordable, coordinated and equitable care.

Even as RUSH grows, its commitment to quality has not wavered. RUSH University Medical Center continues to be rated among the nation's best hospitals this past year, ranking No. 3 for quality in the nation by Vizient and again earning a place on *U.S. News & World Report's* "Best Hospitals" Honor Roll. The magazine also ranked 12 of RUSH University's academic programs among the nation's Top 10. Meanwhile, RUSH's commitment to health equity remains a north star for the organization, with articles in *TIME* and *The New England Journal of Medicine* recognizing RUSH as the national model for this work.

I believe I can speak for all associated with The Woman's Board when I say how proud we feel to play a role in RUSH's success. The Woman's Board has funded leading-edge treatments and technology, endowed chairs and community-based health equity initiatives. In 2022, The Woman's Board raised over \$1.3 million in support of RUSH's mission, including \$500,000 for The Woman's Board Fund for Excellence in Cellular Therapy, which provides critical support to RUSH's bone marrow transplant and cellular therapy research. The Woman's Board also appropriated more than \$466,000 in support of more than 31 grant requests for programs across RUSH's mission.

This level of support is just the beginning of what we can achieve. Your generous support — along with all proceeds from our three fundraisers: the Spring Luncheon, the Fall Benefit and the Annual Appeal — will help The Woman's Board achieve our near-term fundraising commitment of \$500,000 in support of RUSH, its patients and their families. Looking toward the future, RUSH will soon embark on an ambitious initiative to accelerate advances in cancer, neuroscience, bone and joint, innovation, education and workforce development, and health equity. As it does, The Woman's Board remains right by its side with a goal to raise \$10 million over the coming years to help RUSH realize its plans to improve health care.

**In 2022, The Woman's Board of RUSH University Medical Center continued to support RUSH as it navigated an ever-changing health care landscape. Here are just a few of the areas in which you have helped us provide transformational support:**

**Cancer Care** — RUSH is identifying new technologies to create customized and world-class cancer treatment approaches for patients. This year, The Woman's Board Fund for Excellence in Cellular Therapy supported a program focused on new cellular therapy approaches that enable medical specialists to re-engineer a person's own cancer-fighting cells to attack tumors more effectively, breaking new ground in the way lymphoma, leukemia and other hematologic malignancies are treated at RUSH.

**Community Outreach** — The RUSH Community Service Initiatives Program, which provides community-based volunteer experiences for RUSH students, delivers accessible clinical care in West Side communities.

*"Funding from The Woman's Board pays for diagnostic equipment for more than 10,000 people we serve annually and helps us address the death gap by holding health fairs and pop-up heart health events at local churches and community centers," said Sharon Gates, DSW, senior director of student diversity and engagement. "Our pathway programs guide youths down the road of overcoming poverty through education, with a particular focus on a career in health care. One-hundred percent of the students we work with at Crane Medical Preparatory High School graduate."*

**Medical Staff Education and Mental Well-Being** — Educational programs for health care professionals and the public focus on mental health and reduce stigma, encourage diagnosis, and improve quality of care for those affected and their families.

*"Our Psychiatry and Behavioral Sciences Grand Rounds offers health care providers a regularly scheduled time during their fast-paced work lives to keep up to date with important evolving areas of treatment," said Dr. Robert Shulman, acting chair of the Department of Psychiatry and Behavioral Sciences at RUSH University Medical Center. "It also facilitates open and honest discussions about the social and emotional issues they face in caring for patients and families, in addition to exposing them to the latest ground-breaking scientific developments regarding nervous and mental disorders. Its value cannot be understated."*

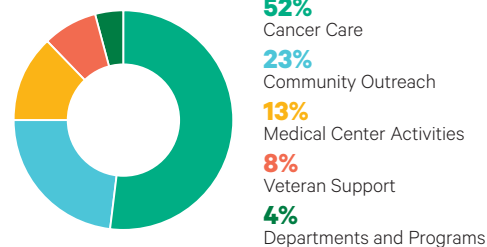
**RUSH Day School** — The therapeutic school provides education for children with autism spectrum disorders and/or children with emotional disabilities.

**Veteran Support** — The Road Home Program provides essential mental health care for veterans and their families.

*"Everyone at Road Home would like to express our gratitude to The Woman's Board," said Brian Klassen, PhD, the program's clinical director. "Their continued generosity allows us not only to maintain access to our specialized post-traumatic stress disorder programs for those who have served, but to innovate the next generation of behavioral health treatments."*

**Women's and Children's Care** — The Kids-Shelter Health Improvement Project, or Kids-SHIP, provides medical care to women and children living in homeless shelters in neighborhoods on the North, West and South Sides. The Newborn Intensive Care Unit purchased newborn car seats and funded programs such as Stop! Asthma at Home and Baby Safety Fairs.
