



# The Woman's Board of Rush University Medical Center

## 2024 IMPACT REPORT

In 2024, The Woman's Board of Rush University Medical Center continued to support Rush as it navigated a constantly evolving health care landscape. Here are just a few of the areas in which you have helped us provide transformational support:

**Research and Innovation:** The Woman's Board fulfilled its **\$500,000** pledge to The Woman's Board Endowed Fund for Research and Clinical Trials at Rush. The fund supports all areas of Rush University Medical Center's groundbreaking research, health care solutions and the expansion of education, professional development and community outreach.

**Additionally, more than 40 grants were awarded to departments across Rush. Just a few are highlighted below.**

**Community Outreach:** A total of **19%** of our annual budget supported outreach programs. This funding provided medications and clinical supplies for more than **10,000** patient interactions by Rush students, full physicals for **86** children who had never been vaccinated or seen a physician, **500** backpacks filled with school supplies, and Lunch-and-Learn sessions for high school students covering health, nutrition and college readiness.

**Mental Health:** A total of **21%** of our budget was allocated to mental health programs, including the Grand Rounds Program, the Road Home Program and Rush Day School. Through Grand Rounds, **13** speakers delivered continuing education to physicians in Rush's Department of Psychiatry.

We supported Socrates 2.0, an innovative multi-AI tool that reduced post-traumatic stress disorder, depression and anxiety symptoms and boosted engagement with the Road Home Program's art therapy services. We also provided **300** welcome bags to new participants.

Rush Day School, which serves children with autism and emotional disabilities, employs **22** full-time faculty and therapists for **33** students. Curricula addressing social-emotional learning and skills in attention, self-awareness and emotional regulation received **71%** of the program's total support.

**Patient Care:** A total of **48%** of our budget supported patient care initiatives. We funded **five** pediatricians who provided care for **200** children in the KidsSHIP program during the first **three** months of the 2024 academic year.

In its first **nine** months, the Rush Center for Breastfeeding and Lactation Medicine served **200** patients.

A total of **80** new ambulatory nurses participated in a 10-week transition-to-practice program, standardizing education and improving care across ambulatory settings.

We supported the launch of CancerIQ, an EPIC-based tool that flags high-risk patients in Oncology and Endocrinology. The tool is expected to increase timely interventions from 13% to **60%** across thousands of patients.
