#### Research and Innovation

In 2025, The Woman's Board proudly fulfilled its **\$500,000** commitment to The Woman's Board Endowed Fund for Research and Clinical Trials at Rush, a transformative investment toward Rush's innovative scientific research and advances in patient-centered care for all.

Additionally, we awarded **35** grants, strengthening our mission by investing in education, professional development and community outreach programs at Rush University Medical Center. A few of these investments are highlighted below.

#### Patient Care

**57%** of our annual budget was allocated to patient care across Rush.

- **We expanded access for vulnerable children** by supporting **5** pediatricians, **10** homeless shelters as part of our Kids Shelter Health Improvement Project (KidsSHIP), and developmental screenings at the CARE Clinic—bypassing up to 2-year waitlists
- **Reduced barriers and readmissions** by funding **40** transportation rides per month and preventing **37+** hospital readmissions
- **Supported breast cancer survivors** by providing specialized post-mastectomy fittings and enabled **12** survivors to receive restorative tattooing as part of their reconstructive journey

#### Community Outreach

**19%** of our annual budget was invested in community outreach across Rush.

- **We supported 250+ children** with school physicals and supplies
- **Improved food access for 2,200+ households** through the Healthy Student Market
- **Expanded youth healthcare access** through Rush's **5** School-Based Health Centers and the Adolescent Family Center, which completed **6,200+** visits

#### Mental Health

**18%** of our annual budget was allocated toward mental health across Rush.

- **We advanced clinical education** with **20+** Grand Rounds speakers for the Psychiatry faculty and staff
- **Empowered families and educators** through the RNBC Executive Function series with **100%** positive parent feedback
- **Expanded access for veterans and families** through the Road Home Program by updating the program's guest houses to ensure that each of the **20** rooms has the same amenities and providing outreach resources that saw a **15%** increase in referrals and **60%** increase in web engagement
